Further, I authorize the CYO Kids Club Staff to contact emergency personnel if any injury or emergency occurs. Qualified personnel may perform emergency treatment as necessary. This authorisation is granted only if I cannot be reached and a reasonable effort has been made to do so.

By signing this form I acknowledge that the C Y O'Connor Village Pub and Tillbrook Nominees Pty Ltd (and its Directors, Employees and Agents) will not be held liable for any injury, death, property damage, lost items, or any other damage that may occur as part of the activities of the CYO Kids Club. Furthermore, by virtue of the exclusion of liability set out above, and upon signing this form, I waive any rights I may have to sue the C Y O'Connor Village Pub and

Tillbrook Nominees Pty Ltd (and its Directors, Employees and Agents) for any perceived or actual shortcomings or omissions in relation to the provision of the activities of the CYO Kids Club and therefore the activities of the CYO Kids Club are undertaken entirely at the participant's own risk and are only allowed on the distinct understanding that the activities are carried out at the participant's own risk.

I am also aware that it is a condition of participation in the CYO Kids Club that as the parent or legal guardian of the participant, I indemnify the C Y O'Connor Village Pub and Tillbrook Nominees Pty Ltd (and its Directors, Employees and Agents) from all and any liability which may arise howsoever from injury and damages howsoever caused (whether fatal or otherwise) which indemnity I hereby irrevocably grant for as long as the child participates in the CYO Kids Club. This shall include any injury suffered through the use of any equipment or facilities at the C Y O'Connor Village Pub and shall include any injury or damage suffered while participating in the activities of the CYO Kids Club or whilst observing those activities or in connection with the CYO Kids Club in any way whatsoever whether attributable to a negligent act, breach of duty of care or default on the part C Y O'Connor Village Pub and Tillbrook Nominees Pty Ltd (and its Directors, Employees and Agents) and acknowledge that I understand that only injuries or damages suffered through deliberate action by C Y O'Connor Village Pub and Tillbrook Nominees Pty Ltd (and its Directors, Employees and Agents) shall be actionable by me.
